2. Submit your Pensioner's declaration forms (P6) in **June** and **December** of each year to provide or declare:

- proof of life;
- any change of address or telephone number;
- if you are receiving a Parent, Widower or Widows pension and have remarried or in a common law relationship
- changes in school status for any child pensioner over 18 years to age 21;
- submit proof of continued education (School letter) in January and September each year for child pensioner over 18 years
